Hazards	Operating Procedure / Control Measures.
<ul style="list-style-type: none"> • <i>Movements between coach, buildings and graveyard.</i> 	<i>The bus/coach to deliver and collect children from the new disability access point. Adults to supervise on/off bus/coach. Adults to be at front/rear of children in pairs when movement on foot is taking place.</i>
<ul style="list-style-type: none"> • <i>Movement into the museum.</i> 	<i>Use new entrance avoiding steep steps.</i>
<ul style="list-style-type: none"> • <i>Movement inside building. Storage heaters are hot to the touch</i> 	<i>Advise pupils of this fact and keep them away from heater.</i>
<ul style="list-style-type: none"> • <i>Road safety/road traffic accident. N.B. Relevant for only the funeral workshop.</i> 	<i>Particular care is required with strict control and clear command when crossing the road. In the event of an accident adults to check pupils for injury Able pupils to be supervised at safe distance from accident e.g. inside the chapel. A member of staff to stay with any injured.</i>
<ul style="list-style-type: none"> • <i>Personal accident (i.e. cuts, graze etc).</i> 	<i>First aid to be administered by the school staff. If the injury could be more serious the emergency services to be called. Tele. Nos. are readily available by entrance & exit points at the chapel, museum & cottage</i>
<ul style="list-style-type: none"> • <i>Asthma attacks.</i> 	<i>First aid to be carried by teacher/pupil concerned. .Emergency numbers are displayed by the front and back doors</i>
Further Action Required: <i>Ensure all persons staffing the visit are aware of and competent to comply with this risk assessment and the control measures.</i>

Group Structure Restrictions	<i>Party to split into groups. 3 or 4 groups will be required for activities at Englesea Brook Groups may be made smaller (6 pupils) for some activities. Secure pupils in safe area while attending to an emergency.</i>
